



## COBALT END USER LICENSE AGREEMENT – FREE TRIAL COBALT SPEECH AND LANGUAGE, INC.

This End User License Agreement, including the Order Form which by this reference is incorporated herein (this "**Agreement**"), is a binding agreement between Cobalt Speech and Language, Inc. ("**Licensor**") and the entity identified on the Order Form as the licensee ("**Licensee**") of the Software (as defined below).

LICENSOR PROVIDES THE SOFTWARE SOLELY ON THE TERMS AND CONDITIONS SET FORTH IN THIS AGREEMENT AND ON THE CONDITION THAT LICENSEE ACCEPTS AND COMPLIES WITH THEM. BY COMPLETING AND SUBMITTING TO LICENSOR A COBALT TRANSCRIBE FREE 100 DAY TRIAL ORDER FORM OR BY DOWNLOADING OR LOGGING ONTO THE SOFTWARE OR CHECKING "YES" IN RESPONSE TO THE QUESTION "DO YOU AGREE TO THE TERMS OF THE FREE TRIAL END USE LICENSE AGREEMENT?" ON AN ORDER FORM, YOU (A) ACCEPT THIS AGREEMENT AND AGREE THAT LICENSEE IS LEGALLY BOUND BY ITS TERMS; AND (B) REPRESENT AND WARRANT THAT: (I) THE LICENSEE IS A CORPORATION OR OTHER LEGAL ENTITY; AND (II) YOU HAVE THE RIGHT, POWER, AND AUTHORITY TO ENTER INTO THIS AGREEMENT ON BEHALF OF LICENSEE AND BIND LICENSEE TO ITS TERMS. IF LICENSEE DOES NOT AGREE TO THE TERMS OF THIS AGREEMENT, LICENSOR WILL NOT AND DOES NOT LICENSE THE SOFTWARE TO LICENSEE AND YOU MUST NOT DOWNLOAD OR INSTALL OR USE THE SOFTWARE OR DOCUMENTATION.

NOTWITHSTANDING ANYTHING TO THE CONTRARY IN THIS AGREEMENT OR YOUR OR LICENSEE'S ACCEPTANCE OF THE TERMS AND CONDITIONS OF THIS AGREEMENT, NO LICENSE IS GRANTED (WHETHER EXPRESSLY, BY IMPLICATION, OR OTHERWISE) UNDER THIS AGREEMENT, AND THIS AGREEMENT EXPRESSLY EXCLUDES ANY RIGHT, CONCERNING ANY SOFTWARE THAT LICENSEE DID NOT ACQUIRE LAWFULLY OR THAT IS NOT A LEGITIMATE, AUTHORIZED COPY OF LICENSOR'S SOFTWARE.

1. Definitions. For purposes of this Agreement, the following terms have the following meanings:

(a) "**Authorized Users**" means employees of Licensee who have been authorized by Licensee to use the Software pursuant to the license granted under this Agreement.

(b) "**Documentation**" means user manuals, technical manuals, and any other materials provided by Licensor, in printed, electronic, or other form, that describe the installation, operation, use, or technical specifications of the Software.

(c) "**Error**" means any failure of the Software to conform in all material respects to its functional specifications as published from time to time by Licensor with respect to which

failure Licensee provides all information requested by Licensor so that Licensor is able to replicate such failure. Any nonconformity, however, resulting from Licensee's or an Authorized User's misuse, improper use, alteration, or damage of the Software, or Licensee's combining or merging the Software with any hardware or software not supplied or identified as compatible by Licensor, shall not be considered an Error.

(d) **"Intellectual Property Rights"** means any and all registered and unregistered rights granted, applied for, or otherwise now or hereafter in existence under or related to any patent, copyright, trademark, trade secret, database protection, or other intellectual property rights laws, and all similar or equivalent rights or forms of protection, in any part of the world.

(e) **"Order Form"** means the order form filled out and submitted by or on behalf of Licensee, and accepted by Licensor relating to the free trial of the license of the Software granted under this Agreement.

(f) **"Person"** means an individual, corporation, partnership, joint venture, limited liability company, governmental authority, unincorporated organization, trust, association, or other entity.

(g) **"Software"** means the software for Cobalt Transcribe, which is a transcription or automatic speech recognition program, along with a general English model for use with Cobalt Transcribe, or any other software programs expressly identified in the Order Form with respect to which Licensee is obtaining a free license in consideration of the terms of this Agreement or delivered to Licensee under this Agreement.

(h) **"Software Open Source Components"** means any open source software provided with or incorporated into the Software, including any available under the GNU Affero General Public License (AGPL), GNU General Public License (GPL), GNU Lesser General Public License (LGPL), Mozilla Public License (MPL), Apache License, BSD licenses, or any other license that is approved by the Open Source Initiative.

(i) **"Term"** has the meaning set forth in Section 9.

(j) **"Third Party"** means any Person other than Licensee or Licensor.

(k) **"Update"** has the meaning set forth in Section 6(b).

2. License Grant and Scope. Subject to and conditioned upon Licensee's strict compliance with all terms and conditions set forth in this Agreement, Licensor hereby grants to Licensee a non-exclusive, non-transferable, non-sublicensable, limited license during the Term to use, solely by and through its Authorized Users, the Software and Documentation, solely as set forth in this Section 2 and subject to all conditions and limitations set forth in Section 4 or elsewhere in this Agreement. This license grants Licensee the right, exercisable solely by and through Licensee's Authorized Users, to:

(a) Download, copy, and install in accordance with the Documentation one (1) copy of the Software on each of up to a total of 100 instances of the Software which are operated on computers owned or leased, and controlled by, Licensee. All copies of the Software made by the Licensee: (i) will be the exclusive property of the Licensor; and (ii) will be subject to the terms and conditions of this Agreement.

(b) Use and run the Software as properly installed in accordance with this Agreement and the Documentation, solely as set forth in the Documentation.

(c) Download or otherwise make one (1) copy of the Documentation per copy of the Software permitted to be downloaded and installed in accordance with this Agreement and use such Documentation, solely in support of its licensed use of the Software in accordance herewith.

(d) As long as Licensee complies with the terms and conditions of this Agreement, Licensee is not obligated to pay any license fees for the license during the Term.

3. Software Open Source Components. The Software includes certain Software Open Source Components. Licensee accepts responsibility to comply with the licenses for the Software Open Source Components that are listed in the license and copyright section of the Software. Licensee may obtain a list of such Software Open Source Components prior to download and installation by requesting such list by email to Licensor at [freetrial@cobaltspeech.com](mailto:freetrial@cobaltspeech.com).

4. Use Restrictions. Licensee shall not, and shall require its Authorized Users not to, directly or indirectly:

(a) use the Software or Documentation beyond the scope of the license granted under Section 2;

(b) provide any other Person, including any subcontractor, independent contractor, affiliate, or service provider of Licensee (“**Subcontractors**”), with access to or use of the Software or Documentation except to the extent such Subcontractors are bound by written confidentiality agreements with Licensee at least as protective of Licensor’s rights as is this Agreement and Licensee is responsible for all actions and inactions of such Subcontractors with respect to Licensee’s obligations under this Agreement;

(c) modify, translate, adapt, or otherwise create derivative works or improvements, whether or not patentable, of the Software or Documentation or any part thereof;

(d) except to the extent that the Order Form reflects that one intended use of the Software is the development of an integrated product, combine the Software or any part thereof with, or incorporate the Software or any part thereof in, any other programs;

(e) reverse engineer, disassemble, decompile, decode, or otherwise attempt to derive or gain access to the source code of the Software or any part thereof;

(f) remove, delete, alter, or obscure any trademarks or any copyright, trademark, patent, or other intellectual property or proprietary rights notices provided on or with the Software or Documentation, including any copy thereof;

(g) attempt to, remove, disable, circumvent, or otherwise create or implement any workaround to, any copy protection or security features of the Software, including any security or usage data reporting features implemented in connection with Section 7 below;

(h) except as expressly set forth in Section 2(a) and Section 2(c), copy the Software or Documentation, in whole or in part;

(i) (except to the extent that the Order Form reflects that one intended use of the Software is to provide the functionality of the Software by way of a service hosted on the cloud), rent, lease, lend, sell, sublicense, assign, distribute, publish, transfer, or otherwise make available

the Software, or any features or functionality of the Software, to any Third Party for any reason, whether or not over a network or on a hosted basis, including in connection with the internet or other technology or service;

(j) use the Software or Documentation in, or in association with, the design, construction, maintenance, or operation of any hazardous environments or systems, including: (i) power generation systems; (ii) aircraft navigation or communication systems, air traffic control systems, or any other transport management systems; (iii) safety-critical applications, including medical or life-support systems, vehicle operation applications, or any police, fire, or other safety response systems; and (iv) military or aerospace applications, weapons systems, or environments;

(k) use the Software or Documentation in violation of any law, regulation, or rule;

(l) export, re-export, or release the Software or Documentation to, or make the Software or Documentation accessible outside the United States without entering into a separate agreement with Licensor; (Please contact [sales@cobaltspeech.com](mailto:sales@cobaltspeech.com) to discuss international licenses.)

(m) provide the Software to a federal government agency or other government entity, including the United States Department of Defense without entering into a separate agreement with Licensor; or

(n) use the Software or Documentation for purposes of competitive analysis or benchmarking of the Software (unless such competitive analysis and benchmarking is kept strictly confidential and not disclosed to any third party), the development of a competing software product or service, or any use of the Software or Documentation by a company that provides its own proprietary and competing speech recognition product to customers.

5. Responsibility for Use of Software. Licensee is responsible and liable for all uses of the Software and Documentation through access thereto provided by Licensee, directly or indirectly. Specifically, and without limiting the generality of the foregoing, Licensee is responsible and liable for all actions and failures to take required actions with respect to the Software and Documentation by its Authorized Users or by any other Person to whom Licensee or an Authorized User may provide access to or use of the Software or Documentation, whether such access or use is permitted by or in violation of this Agreement.

6. Maintenance and Support.

(a) The license granted hereunder entitles Licensee during the Term to such basic software maintenance and support services described in this Section 6 as Licensor may in its sole discretion elect to provide (the “**Support Services**”).

(b) Support Services will include provision of such updates, upgrades, bug fixes, patches, and other Error corrections (collectively, “**Updates**”) as Licensor makes generally available free of charge to all licensees of the Software then entitled to maintenance and support services. Licensor may develop and provide Updates in its sole discretion, and Licensee agrees that Licensor has no obligation to develop any Updates at all or for particular issues. Licensee further agrees that all Updates will be deemed Software, and related documentation will be deemed Documentation, all subject to all terms and conditions of this Agreement.

(c) Support Services with respect to correcting Errors will be limited to the following: (i) Licensee will email information about an Error to Licensee at [freetrial@CobaltSpeech.com](mailto:freetrial@CobaltSpeech.com) and provide sufficient information about the bug so that Licensor's team can replicate such Error or such other method as Licensor may direct (each, a "Request"); (ii) Licensor will make reasonable efforts to acknowledge and begin working on each Request within two (2) business days of receiving such Request; and (iii) Licensor, in its sole discretion, will respond to each Request by doing one or more of the following: (A) providing Licensee with email advice as to how to resolve the issue; (B) releasing an Update which Licensor believes will fix or ameliorate the Error; (C) deferring work on the Error until a later date; or (D) determining that the Error is not of sufficient general interest to its customers to warrant further effort. Licensor may, in its sole discretion, provide technical support for integrating the Software with Licensee's software, platform or solution.

7. Collection and Use of Information.

Licensee acknowledges that Licensor may, directly or indirectly through the services of Third Parties, collect and store information regarding use of the Software and about equipment on which the Software is installed or through which it otherwise is accessed and used, through the provision of Support Services and security measures included in the Software as described in Section 4(g). Licensee agrees that the Licensor may use such information for any purpose related to any use of the Software by Licensee or on Licensee's equipment, including but not limited to: (i) improving the performance of the Software or developing Updates; and (ii) verifying Licensee's compliance with the terms of this Agreement and enforcing the Licensor's rights, including all Intellectual Property Rights in and to the Software.

8. Intellectual Property Rights. Licensee acknowledges and agrees that the Software and Documentation are provided under license, and not sold, to Licensee. Licensee does not acquire any ownership interest in the Software or Documentation under this Agreement, or any other rights thereto, other than to use the same in accordance with the license granted and subject to all terms, conditions, and restrictions under this Agreement. Licensor and its licensors reserve and shall retain their entire right, title, and interest in and to the Software and all Intellectual Property Rights arising out of or relating to the Software, except as expressly granted to the Licensee in this Agreement. Licensee shall use commercially reasonable efforts to safeguard all Software (including all copies thereof) from infringement, misappropriation, theft, misuse, or unauthorized access. Licensee shall promptly notify Licensor if Licensee becomes aware of any infringement of the Licensor's Intellectual Property Rights in the Software and fully cooperate with Licensor in any legal action taken by Licensor to enforce its Intellectual Property Rights.

9. Term and Termination.

This Agreement and the license granted hereunder shall remain in effect for 100 days from acceptance by Licensor or until earlier terminated as set forth herein (the "Term"). Licensee may terminate this Agreement by ceasing to use and destroying all copies of the Software and Documentation and giving written notice to Licensor. Licensor may terminate this Agreement, effective upon written notice to Licensee, if Licensee, breaches this Agreement. Licensor may terminate this Agreement, effective immediately, if Licensee files, or has filed against it, a petition for voluntary or involuntary bankruptcy or pursuant to any other insolvency

law, makes or seeks to make a general assignment for the benefit of its creditors or applies for, or consents to, the appointment of a trustee, receiver, or custodian for a substantial part of its property. Upon expiration or earlier termination of this Agreement, the license granted hereunder shall also terminate, and Licensee shall cease using and destroy all copies of the Software and Documentation.

10. Warranty Disclaimer.

(a) THE SOFTWARE AND DOCUMENTATION ARE PROVIDED TO LICENSEE "AS IS" AND WITH ALL FAULTS AND DEFECTS WITHOUT WARRANTY OF ANY KIND. TO THE MAXIMUM EXTENT PERMITTED UNDER APPLICABLE LAW, LICENSOR, ON ITS OWN BEHALF AND ON BEHALF OF ITS AFFILIATES AND ITS AND THEIR RESPECTIVE LICENSORS AND SERVICE PROVIDERS, EXPRESSLY DISCLAIMS ALL WARRANTIES, WHETHER EXPRESS, IMPLIED, STATUTORY, OR OTHERWISE, WITH RESPECT TO THE SOFTWARE AND DOCUMENTATION, INCLUDING ALL IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, TITLE, AND NON-INFRINGEMENT, AND WARRANTIES THAT MAY ARISE OUT OF COURSE OF DEALING, COURSE OF PERFORMANCE, USAGE, OR TRADE PRACTICE. WITHOUT LIMITATION TO THE FOREGOING, THE LICENSOR PROVIDES NO WARRANTY OR UNDERTAKING, AND MAKES NO REPRESENTATION OF ANY KIND THAT THE LICENSED SOFTWARE WILL MEET THE LICENSEE'S REQUIREMENTS, ACHIEVE ANY INTENDED RESULTS, BE COMPATIBLE, OR WORK WITH ANY OTHER SOFTWARE, APPLICATIONS, SYSTEMS, OR SERVICES, OPERATE WITHOUT INTERRUPTION, MEET ANY PERFORMANCE OR RELIABILITY STANDARDS OR BE ERROR FREE, OR THAT ANY ERRORS OR DEFECTS CAN OR WILL BE CORRECTED.

11. Limitation of Liability. TO THE FULLEST EXTENT PERMITTED UNDER APPLICABLE LAW:

(a) IN NO EVENT WILL LICENSOR OR ITS AFFILIATES, OR ANY OF ITS OR THEIR RESPECTIVE LICENSORS OR SERVICE PROVIDERS, BE LIABLE TO LICENSEE OR ANY THIRD PARTY FOR ANY USE, INTERRUPTION, DELAY, OR INABILITY TO USE THE SOFTWARE; OR FOR ANY CONSEQUENTIAL, INCIDENTAL, INDIRECT, EXEMPLARY, SPECIAL, OR PUNITIVE DAMAGES, WHETHER ARISING OUT OF OR IN CONNECTION WITH THIS AGREEMENT, BREACH OF CONTRACT, TORT (INCLUDING NEGLIGENCE), OR OTHERWISE, REGARDLESS OF WHETHER SUCH DAMAGES WERE FORESEEABLE AND WHETHER OR NOT THE LICENSOR WAS ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

(b) IN NO EVENT WILL LICENSOR'S AND ITS AFFILIATES', INCLUDING ANY OF ITS OR THEIR RESPECTIVE LICENSORS' AND SERVICE PROVIDERS', COLLECTIVE AGGREGATE LIABILITY UNDER OR IN CONNECTION WITH THIS AGREEMENT OR ITS SUBJECT MATTER, UNDER ANY LEGAL OR EQUITABLE THEORY, INCLUDING BREACH OF CONTRACT, TORT (INCLUDING NEGLIGENCE), STRICT LIABILITY, AND OTHERWISE, EXCEED ONE HUNDRED UNITED STATES DOLLARS.

(c) THE LIMITATIONS SET FORTH IN SECTION 11(a) AND SECTION 11(b) SHALL APPLY EVEN IF THE LICENSEE'S REMEDIES UNDER THIS AGREEMENT FAIL OF THEIR ESSENTIAL PURPOSE.

12. Miscellaneous.

(a) All matters arising out of or relating to this Agreement shall be governed by and construed in accordance with the internal laws of the Commonwealth of Massachusetts without giving effect to any choice or conflict of law provision or rule. Any legal suit, action, or proceeding arising out of or relating to this Agreement or the transactions contemplated hereby shall be instituted in the federal courts of the United States of America or the courts of the Commonwealth of Massachusetts in each case located in the City of Boston and County of Suffolk, and each party irrevocably submits to the exclusive jurisdiction of such courts in any such legal suit, action, or proceeding.

(b) All notices, requests, consents, claims, demands, waivers, and other communications hereunder shall be in writing and shall be deemed to have been given: (i) when delivered by hand; (ii) when received by the addressee if sent by a nationally recognized overnight courier (receipt requested); (iii) on the date sent by email (with confirmation of transmission) if sent during normal business hours of the recipient, and on the next business day if sent after normal business hours of the recipient; or (iv) on the third day after the date mailed, by certified or registered mail, return receipt requested, postage prepaid. Such communications must be sent (I) if to Licensor, to Cobalt Speech and Language, Inc., 29 Scribner Rd, Tyngsboro, MA 01879; and (II) if to Licensee, to the address set forth on the Order Form, or to such other address as may be designated by a party from time to time in accordance with this Section 12(b).

(c) This Agreement, together with the Order Form, constitutes the sole and entire agreement between Licensee and Licensor with respect to the subject matter contained herein, and supersedes all prior and contemporaneous understandings, agreements, representations, and warranties, both written and oral, with respect to such subject matter.

(d) Licensee shall not assign or otherwise transfer any of its rights, or delegate or otherwise transfer any of its obligations or performance, under this Agreement, in each case whether voluntarily, involuntarily, by operation of law, or otherwise. Any purported assignment, delegation, or transfer in violation of this Section 12(d) is void. Licensor may freely assign or otherwise transfer all or any of its rights, or delegate or otherwise transfer all or any of its obligations or performance, under this Agreement without Licensee's consent. This Agreement is binding upon and inures to the benefit of the parties hereto and their respective permitted successors and assigns. This Agreement is for the sole benefit of the parties hereto and their respective successors and permitted assigns and nothing herein, express or implied, is intended to or shall confer on any other Person any legal or equitable right, benefit, or remedy of any nature whatsoever under or by reason of this Agreement.

(e) This Agreement may only be amended, modified, or supplemented by an agreement in writing signed by each party hereto. No waiver by any party of any of the provisions hereof shall be effective unless explicitly set forth in writing and signed by the party so waiving. Except as otherwise set forth in this Agreement, no failure to exercise, or delay in

exercising, any right, remedy, power, or privilege arising from this Agreement shall operate or be construed as a waiver thereof; nor shall any single or partial exercise of any right, remedy, power, or privilege hereunder preclude any other or further exercise thereof or the exercise of any other right, remedy, power, or privilege.

(f) If any term or provision of this Agreement is invalid, illegal, or unenforceable in any jurisdiction, such invalidity, illegality, or unenforceability shall not affect any other term or provision of this Agreement or invalidate or render unenforceable such term or provision in any other jurisdiction. For purposes of this Agreement, (a) the words "include," "includes," and "including" shall be deemed to be followed by the words "without limitation"; and (b) the word "or" is not exclusive. The headings in this Agreement are for reference only and do not affect the interpretation of this Agreement.
